Website ownership

You are not allowed to use this website and/or receive services if doing so is prohibited in your country or under any law or regulation applicable to you.

Commercial Terms

When buying an item, you agree that: (i) you are responsible for reading the full item listing before making a commitment to buy it: (ii) you enter into a legally binding contract to purchase an item when you commit to buy an item and you complete the check-out payment process.

The prices of Artwork-e-v charge for using our services / for our products are listed on the website. We reserve the right to change our prices for products displayed at any time, and to correct pricing errors that may inadvertently occur. Return and refund policy

While every effort has been made to portray artworks accurately, slight variations may occur. All measurements quoted are approximate and the reproduction of colours and finishes is as accurate as photographic and publishing processes will allow within the context of the site where images were taken. Please note there may be variations in colours dependant on the calibration and settings of individual screens, and differing lighting conditions. Due to the organic nature of materials used in artworks, colours may appear different to the naked eye. If accurate colour or surface finish is required, please contact us to request detailed images or samples prior to purchase. To not do so, is at your own risk and we do not take responsibility for artworks not meeting expectations in relation to appearance or size.

If you are unhappy with an artwork, you must be in touch via artwork.e.v@gmail.com within 14 days of receipt of the goods. If agreed via email you may send the artwork back, only if contained within the original packaging and in perfect condition; Artwork-e-v will only then issue a refund or exchange. This is solely granted as a goodwill gesture, and the offer may be retracted at any time. Returns/exchanges do not apply to commissioned artworks or bespoke orders of any kind.

Postage, packaging and Insurance incurred in the returns process are non-refundable, nor the original shipping fee paid at point of sale. This does not affect your statutory rights. You will be responsible for the cost of returning the artworks to us, including any incurred import duties, and will remain responsible for any and all returned artworks until they reach my premises. Please note that One-Off pieces and Edition items can only be returned or exchanged if faulty. A change of mind on behalf of the customer due to appearance or size of an artwork does constitute it's eligibility for return.

Agreed returns will be refunded only on receipt of shipment and after a thorough inspection has been approved by artwork.e.v@gmail.com. Refunds amount only to the 'Cost of Artwork' as stated in the original invoice or website listing, and will be issued in EURO. All refunds are made at the prevailing exchange rate andwedo not takeresponsibilityfor any fluctuations incurrency value between the date of the original invoice andthe date of the relevant refund. A returns address will be issued via email if deemed eligible.

Delivery of Goods

All artworks will only be shipped on completion of payment in full, via courier only unless otherwise contractually agreed.

Please note any incurred import duties when shipping artworks internationally from France are the sole responsibility of the customer/client. Correct customs documents will be included with each shipment or supplied directly to the courier on request. This will be done by Artwork-e-v in direct communication and co-operation with the customer. This relies on accurate information being supplied by the customer before shipment is sent. When signing for delivery of artworks from a courier, please either check the item with courier, or sign 'unchecked'. Artwork-e-v will not be held responsible for goods damaged during transport, if they are signed for at destination. No Claim regarding damage, shortage or defect will be considered unless reported within 24 hours from receipt of goods.

Full instructions will be supplied on delivery, including cleaning and care advice if requested by the customer/client.
